## Recently in the News

### Carie Lemack's Film Nominated for Oscar

A month after their mother, Judy Larocque, was killed on AA Flight 11, Carie Lemack and her older sister Danielle co-founded Families of September 11 to press for answers, to demand accountability, and to give voice to the voiceless. Since then, Carie has advocated for victims of terror, worked to create policies and laws to improve security, and helped promote communication and understanding in an effort to bring an end to terrorism.

In 2005, a suicide bomber in Amman, Jordan detonated himself at a Muslim wedding, killing 27 members of the wedding party. Carie met the groom, Ashraf al-Khaled, at a United Nations symposium for survivors of terrorism in 2008. (His wife survived, too, but three of their parents died.) Together in November 2009, Lemack and al-Khaled formed the Global Survivors Network, which aspires to prevent future acts of terror by giving voice to those who survived past ones. As part of their message, **Lemack executive-produced "Killing in the Name,"** about al-Khaled's efforts to confront radicalized Muslims with his pain. The 38-minute film was recently nominated for an Oscar. "I'm just so thrilled," she said. "It was so painful and so awful ... We are going to make something positive so the whole world can see." ### Maintenance of Boston Public Garden Memorial

Many of you may have seen in the news that there has been some minor vandalism to the granite of the The Garden of Remembrance Memorial in the Boston Public Garden. It's likely that the scrapes on the top edge of the granite have been caused by skateboarders. Since the apparent skateboarding has continued since first discovering the damage in 2009, the Parks Commission has agreed to install a "post and chain" barrier on the back side of the Memorial monument to hinder skate boarders. We believe this will provide a deterrent with the least possible change in the appearance of the Garden of Remembrance Memorial site. The application for the post and chain was recently approved and we plan to complete the installation before the annual commemoration.

Families will again have an opportunity to submit their photos and memorabilia to the 9/11 Memorial Museum at Ground Zero when representatives from Voices of September 11 and the Museum come to Boston.

**Voices of September 11** will be coming to the Wellesley Free Public Library on Thursday, May 5, from 10 a.m. to 5 p.m. to scan and organize photographs and personal keepsakes for inclusion in the 9/11 Living Memorial Project. The library is located at 530 Washington Street in Wellesley. **The 9/11 Living Memorial Project** is a digital archive currently online at [www.911livingmemorial.org](http://www.911livingmemorial.org) that chronicles the lives of the nearly 3,000 lives lost in the 9/11 attacks, and documents the inspirational stories of survivors, rescue and recovery workers.

Participants are invited to bring in photographs, written tributes, eulogies, biographies, newspaper articles and other personal keepsakes that will create a meaningful legacy to honor those who died and to document your personal story for future generations. Unless otherwise arranged, all materials will be returned at the workshop.

During the third week in May, representatives from the National September 11 Memorial and Museum will come to the South Shore and Newton for appointments to do interviews and gather photos and memorabilia to be included in their rotating exhibit. First day appointments will held at Hope Floats in Kingston, and the second day appointments will be held at the Newton Historical Society. By offering two locations, we hope to make it easier for families to meet with them. Details on time and date will follow via e-mail.
