## Commemoration 2007 – Planning Committees Forming Now

Interested in shaping the 2007 Commemoration services in Boston this year? Consider joining one of the committees below – each of which will have an important role in planning the different parts of this year's services. We'd like to recruit family members to these committees before the end of the month, so if you are interested in joining one of the groups described below, be sure to let Diane Nealon at the Fund know your committee choice **before Wednesday, April 25<sup>th</sup>**. Introductory meetings of all committees will begin in May.

**State House Ceremony Committee**

This committee will meet at least once a month initially, and as September 11<sup>th</sup> draws closer, probably semi-monthly. Action items will include music selection, recruitment of speakers, name readers, organization of the volunteers, program design and development of a media strategy.

**Sweeney Award Outreach Committee**

This committee will meet monthly from May to July in order to help publicize the award and solicit as many nominations as possible throughout the Commonwealth. If you have public relations experience, we welcome your input.

**Luncheon Committee**

This committee will meet at least once a month initially, and as September 11<sup>th</sup> draws closer, more frequently. Action items will include menu selection, seating plan, ballroom and reception layout, development of activities for the children's room and organization of volunteers.

### Updates from City of NY Medical Examiner's Office

We recognize that there has been increased attention on the ongoing search and recovery of remains at Ground Zero from the media and other family groups. **Family members interested in receiving timely first-hand updates from the City of New York Mayor's Office and Medical Examiner's Office regarding these efforts are encouraged to register with Diane Nealon at the Fund for this purpose.** We have established a regular schedule of contact with these offices and can provide interested family members with accurate, current information about this important and sensitive work. In addition, the Medical Examiner's Office has let us know that many addresses they have for family members for notification purposes are now out of date – therefore, if you have moved within the last five years, you may wish to update your contact information with the Medical Examiner's Office by contacting them at **212-447-2030**. If you need assistance communicating with the Medical Examiner's Office, please do not hesitate to let Diane know.

We realize that some family members do not wish to receive emails or updates from us regarding these issues. If that is the case, please be sure to let Diane know.

## Online Teen Chat Project – A Collaboration between Families of September 11<sup>th</sup> & The Good Grief Program

We are pleased to share information about a terrific collaboration being developed between **Families of September 11<sup>th</sup>** (FOS11) and **Boston Medical Center's Good Grief Program** for an online teen chat program. Participants in the program can share experiences related to 9/11 in a safe environment facilitated by FOS11 Advisory Board Member Dr. Donna Gaffney. To ensure safety, a secure sign-in process will be used and all participants need signed permission forms. Before the project is kicked off, FOS11 and Boston Medical Center invite teens aged 16-19 to participate in a focus group in order to help the staff develop a program best suited to their needs. Dates being considered include April 27<sup>th</sup>, April 30<sup>th</sup> and May 9<sup>th</sup>; the location will be determined based upon the convenience of the participants. **To sign up for the focus group, please contact Deborah Rivlin at Boston Medical Center's Good Grief Program at 617-414-3616.** If you would like more information about the program, please don't hesitate to contact Deborah Rivlin or Families of September 11<sup>th</sup> at **212-575-1878**. ## Voices of September 11<sup>th</sup> to Bring 9/11 Living Memorial Workshops to Boston

The MA 9/11 Fund is pleased to host a day of workshops brought to you by Voices of September 11<sup>th</sup> for those family members interested in learning more and possibly contributing to the **9/11 Living Memorial**, a permanent, web-based digital archive commemorating the lives and stories of September 11, 2001 and the February 26, 1993 WTC bombing. The site will eventually be incorporated into a portal at the to-be-built WTC Memorial Museum as a core component of the Museum's digital resource center and available to the Library of Congress. The workshops will be conducted on **Thursday, May 17<sup>th</sup>** at the offices of the Fund in Boston from **2p-4p** and again from **6p-8p**. Professional staff will assist families, rescue workers and survivors to organize commemorative keepsakes, photographs and write personal tributes. State-of-the-art technology will be used to effectively digitize, archive multidimensional content. ### Health Care Support Program – Year Two
