Remembrance and Reflection at the Memorial Garden

Following the news of Osama Bin Laden's death, on May 2, 2011, the Mass 9/11 Fund organized a moving and thoughtful event to honor our loved ones who were lost on September 11. Families and local dignitaries were invited to share in a moment of silence. Following the period of reflection, attendees placed 206 white roses on the memorial, each one representing a New England family member killed on September 11. It was a beautiful moment to remember our loved ones.

Mass 9/11 Families Share Feelings and Receive Support

In response to requests from Mass 9/11 families, a reflection and support reception was held Friday, May 13, 2011 at Les Zygomates Restaurant in Boston. Following the dinner, family members expressed how they felt about the news of Osama bin Laden's death.

Diane Nealon, LICSW led discussions and offered understanding and support to family members who were again dealing with emotional and physical reactions similar to those they felt after the attacks on 9/11. Beth Chambers, Director of Community Services for Catholic Charities and Erin Heenan were also on hand to lend their support. At the end of the evening, there was a consensus from family members that more gatherings of this nature would be helpful in the future as we continue to respond to events in the aftermath of 9/11.

9/11 Families Honor Memorial Day with MMHF Families

As part of our 2nd quarter service project, several 9/11 family members participated in the Mass Military Heroes' Fund's (MMHF) 2nd Annual Memorial Day tribute by helping to plant 20,000 flags in the grass on the Boston Common on the Wednesday before Memorial Day. Some also attended the Name-reading Ceremony on Thursday morning, at which time MMHF family members, friends, and dignitaries symbolically planted 143 flags in honor of those who were killed in Afghanistan or Iraq. Governor Deval Patrick, Attorney General Martha Coakley, and Mayor Tom Menino spoke at the ceremony.

MMHF created the tribute last year as a way to remind people of the true meaning of Memorial Day. Each of the 20,000 flags represented a Massachusetts service member killed in service to our country since World War I. Hundreds of people visited the display each day. The flags made a sobering statement as they waved in the breeze on the sloping hill just below the Sailors and Soldiers Monument on the Common.

9/11 Memorial Historian Visits Massachusetts

On May 16, Oral Historian for Exhibitions, Jenny Pachucki from the 9/11 Memorial Museum in New York met with families at the Children's Room in Arlington, MA. Ten families took this opportunity to submit photographs, memorabilia and record anecdotes and recollections of their loved one. Each recording will be professionally edited into a 3 minute audio segment that will become part of the museum's interactive archive.

The organization has been funded to provide free transportation for those who specify a financial hardship by stating that they would not otherwise be able to attend one of these events without some assistance. There is no requirement to substantiate your individual financial circumstances. **Please note the deadline date of July 1.**

Upcoming Service Projects

9/11 Day of Service Projects

The Mass 9/11Fund will again be associated with two worthy service projects on September 11 this year. The projects are being coordinated in recognition of the anniversary of 9/11 as a National Day of Service and Remembrance.

MMHF Care Package Drive

The Mass Military Heroes Fund will host its Third Annual Care Package Drive on the Rose Kennedy Greenway (near Quincy Market/The Aquarium) in honor of our loved ones who died. Packages will be sent to soldiers currently serving in Iraq and Afghanistan. Families are invited to participate by helping to assemble packages, address labels, and write notes, etc. The event begins at 11:00 a.m. and ends between 1:00-2:00 p.m., so there's time to help after our annual brunch at the Ritz Carlton. Additional help and support can be provided by asking your company or your children's school to hold a drive to collect the items we need in quantities of 500. American Red Cross Blood Drive at Fenway Park

The American Red Cross will again be hosting its "Day of Remembrance" blood drive at Fenway Park from 8:00 a.m. to 3:00 p.m. on September 11. The 8th annual event encourages the public to honor this solemn day by giving blood in memory of those who died on 9/11. Each pint of blood donated can help save up to three lives. Sixteen year olds are now eligible to donate, and 9/11 family members will be escorted to the VIP area to expedite the process. Transportation will be provided by the American Red Cross from within the city of Boston to Fenway Park. Family members who choose not to or cannot donate are welcome to stop by to greet and thank donors for giving in our loved ones' memory.
