12th Anniversary Commemoration

A Day to Reflect and Remember

The 12th anniversary of the tragic day that brought us all together has come and gone. As in the past, family members came together at the Public Garden, the State House steps and Chambers, and the Ritz Carlton for the 12th Anniversary Commemoration of September 11.

Following the annual reading of the names on the State House steps, the families were addressed by Boston Police Commissioner Edward Davis. Juliette Candela sang the song, "I will Remember You" by Sarah McLachlan at the State House Commemoration Observance. She is a Freshman at the Berklee College of Music. She sang in memory of her father, John Candela, who worked at Cantor Fitzgerald. Her father inspired her love for music.

We were honored to have Bill Richard join us at this year's commemoration. The Richard family was devastated by the Boston Marathon bombings. His son Martin was killed, his wife Denise was severely injured, and his daughter Jane lost part of her leg. During the ceremony, Bill read the following poem to the families and friends in attendance.

"We sit beneath the night sky by the whisper of the wind's song and the quiet of darkness and they are never far. Those we have loved and cherished, those who have changed our lives in some small or profound way are closer than we know because it is their light that shines on our world. It is the brilliance of their souls that makes our night sky glow."

2013 Madeline Amy Sweeney Award for Civilian Bravery

Given the tragic Boston Marathon bombings which resulted in the death of 4 people and injured more than 200, the friends and families of the Mass 9/11 Fund felt that it was especially fitting that the award recipient was Carlos Arrendondo.

"United We Stand" License Promotion at the Big E

On September 19, the Mass 9/11 Fund was invited by the Mass Department of Motor Vehicles to promote our specialty plate, "United We Stand," at the Big E (New England State Fair) in Springfield, MA. Family Advisory Committee members manned the RMV booth to garner more interest in our specialty plates. United We Stand plates commemorate the loss of lives from the terrorist attacks on September 11, 2001. We continue to unite and combat issues of terrorism in a unified common goal, while never forgetting what happened on 9/11. The revenue earned from the sale of these specially designated plates is invaluable to the support and continuance of this mission, WE WILL NEVER FORGET.

Family members interested in the "United We Stand" plates may call 857-368-8031. When you call, you will be assigned a numbered plate between 1000 and 1200. This series is reserved for 9/11 family members only and comes with a "Remember" sticker. Anyone who is not a family member and would like to show his/her support may call 857-368-8000. The initial cost of the plate is \$90.00 and is renewable for two years for \$90.00. If the "Remember" sticker on your license plate has worn off, call the family number above to request a replacement.

Letter from 9/11 Memorial Museum Call to Remember Initiative

Dear Family Members,

At this juncture, we are encouraging the participation of families in our **CALL TO REMEMBER** initiative, which will allow them to use their personal phones to record a story or memory of a loved one from the comfort and privacy of their homes. These sessions enable contributors to leave a remembrance of up to 10 minutes in length. They can opt to re-record, if they prefer, prior to releasing it to our archive.

In order to associate the recording with the correct individual being remembered, families are encouraged to be in touch with Jenny Pachucki, our oral historian (jpachucki@911memorial.org ; 212-312-8785) who can provide them with the **unique identification number** of their loved one, which will be entered after a recorded voice prompt requests it.

CALL TO REMEMBER INSTRUCTIONS

Each step is completed after you have spoken by pressing the * key (Star Key)

- 1) Please dial (866) 582-5613 (Toll Free) or (646) 248-6225 (Local).
- 2) When connected, you will hear a recorded voice welcoming you to the service and explaining the recording process. You will then be asked to enter a 4-digit identification code for the person you are intending to remember. **The 4-digit code for Jenny is 1594.**
- 3) Your recording may be as simple as your name and your relationship to the person you are calling to remember.
- 4) You will be prompted to leave your name. Please say your full name clearly and then press star.
- 5) You will be prompted to leave your loved one's name and your relationship to him/her, then press star. Stating your relationship following the format of the examples below will ensure that the museum team will be better suited to include it as part of the remembrance collage at the gallery threshold of the memorial exhibition.
 - My name is Jane Smith - my beloved husband, John Smith
 - My name is Robert Jones - my friend, Rebecca Dawson
 - My name is Albert Thomas - my father, Benjamin Thomas
- 6) If you wish to record a longer remembrance you are welcome to at this point. It might be helpful to imagine that you are talking with a friend. We invite you to share whatever you'd like: favorite stories about your loved one, personality traits, hobbies and anything that will help others to understand why he or she was special to you.
- 7) You can press the star key to skip the longer remembrance option and proceed to the permissions section of the recording.
- 8) When you have completed your recording and pressed the star key you will be asked to give permission to incorporate your recording into our archive and exhibition. Please state clearly "I agree" and press the star key. You may hang up after you hear the prompt thanking you for your participation.

Small, personal items are always welcome, as are between 3-10 photographs depicting loved ones in the many dimensions of his or her life. We are able to scan original photographs and will return them to families. We also welcome receipt of these images in digital form, as electronic attachments. All contributors will be asked to provide caption information relevant to the images (i.e. who is depicted, when, where, and the occasion, if known). They will also receive, for review and signature, an official Deed of Gift form which will enable donors to determine the scope of "rights" they wish to grant to the Museum for various potential uses of these images beyond the Memorial Exhibition, such as in various educational programs or on-line interpretive presentations.

Do You Have Something to Share with Other Families?

Family members who wish to contribute a letter, article or news item for publication in an upcoming quarterly newsletter can do so by e-mailing it to alyse.mazerolle@massfund.org. Each piece submitted will be reviewed and, if approved by the Family Advisory Committee and the Board, will be published in an upcoming newsletter. 2014 submission deadlines are: February 1, June 1, August 1 and November 1.
