Progress Reports on Priority Projects

The families, board and staff members have been busy these last few weeks, putting in efforts on a variety of projects. Let's get right to the updates!

Scholarship America

We have joined together with Voices of September 11 - a very proactive organization based in Connecticut. Their issues and ours are shared. Both believe that Scholarship America can and must do a better job of addressing what the donors to the 9/11 scholarships desired - to support the education of those affected. Our Board President and Executive Director have both had conversations with individuals there, and most recently David participated in a conference call on June 9 to plan the strategy going forward as a united front representing the families. The issues on which we are concentrating are the policies regarding not recognizing 100% of the unmet educational expense needs, the stated intention of allocating unused balances to non 9/11 affected persons, and the need to recognize educational expenses beyond those of post-secondary schooling.

Child and Adolescent Program

The Fund and Children's Charter held a meeting on Saturday, June 4th for children interested in learning more information about participating in a series of therapeutic workshops using innovative technology, such as Computer Programming of 3D Art, TV Production, Audio Broadcasting and Music Video Production. Several families have expressed interest in these workshops, but were unable to attend the meeting on the 4th. Remembrance Book - "we remember"

The Remembrance Book Project is moving full steam ahead!! The volume, titled, "we remember" is comprised of three parts. The first is an introductory book containing words from family and board members, some signatures provided of loved ones lost on 9/11, and a listing of family foundations and scholarships. The other two parts are the two volumes of bound individual layouts, thirty-eight in each volume. Together, the three parts are assembled in a memory box, which can be placed on a flat surface, or standing on a bookshelf. We have made every effort to contact the family members that chose to participate in the project with the intent of providing an opportunity to review their individual submission. Expansion of Newsletter Distribution

As you may recall, the Community of Care is a group of local agencies and wellness/recovery providers who meet regularly to share information about program needs in the 9/11 family community. Currently, the Community consists of representatives from the American Red Cross, the Massachusetts Department of Mental Health, Boston Medical Center, Senator Kennedy's Office, the Massachusetts Office for Victim Assistance, Catholic Charities, Cambridge Health Alliance, Brockton Family and Community Resources, Adam Lesser, LICSW, Children's Charter and the U.S. Attorney's Office. The Massachusetts 9/11 Fund has invited the Community of Care to share items of interest in this newsletter and we will provide copies of our newsletter to them on a regular basis.

Sports Field Dedicated in Honor of Massachusetts 9/11 Loved Ones

David had the honor of representing the families at a dedication for a truly wonderful sports field available to all those in Massachusetts. In a testimony to perseverance, dedication of local and state government officials, and multiple individual citizens and small businesses, this project

came to fruition after more than eight years of hard work. The total cost of donated services exceeded \$2,000,000 and has resulted in a twelve-month artificial turf football/soccer/lacrosse field complete with grandstands.

Halfway through the creation of this field the events of 9/11/01 occurred. Joe Kacevich, the inspiration for and creator of this significant effort, declared that it should continue and go forward in the names of Massachusetts victims of 9/11. Working with Senator Ted Kennedy's office, he obtained the full listing of names as they appear on the Living Memorial in the Boston Public Garden. Lovingly, a memorial stone listing those overlooks this field. Together with an American Flag, it will be lit through all hours of the night thanks to a solar powered lighting system. In these ways the field is sustainable into the future - not requiring watering, mowing or pesticides to control weeds, and not using fossil fuels to power the lights for the memorial. There is also a handicapped-accessible walkway all the way from the parking area to the memorial, the work of a Southborough, Massachusetts Eagle Scout. A letter written by Mr. Kacevich to two of our family members, who were able to attend the dedication, follows. I invite you to take him up on his offer of not only viewing the field, but of using it. Once the final pieces are completed (the signage and the solar lighting), we will invite all of you - the families - to attend a special ceremony dedicating the field in honor of your loved ones. Here is Joe's letter. It speaks for itself. I've deleted the names of the folks to whom Joe wrote:

Dear ...,

It was a privilege to meet you on Memorial Day at the dedication ceremony. Although it was not under ideal conditions, hopefully you have an idea of how much our community supported the wonderful facility that 9-11 Memorial Field has become. It truly is a state-wide facility. Under the terms of the Agreement with the Department of Conservation and Recreation, the property owners, Southborough receives 75% of the available playing time (in return for maintaining the facility) and literally any town in the Commonwealth can apply to use the remaining 25% time allotment. On any given week, you will see kids and adults from all over Central Massachusetts using the Field. Now that the monument has been unveiled, we will make it a point to have all users of 9-11 to take the time to observe the monument.

All of the speakers did a wonderful job in articulating that the facility stands for the future of our kids. While the terrorists broke the hearts of many families and caused untold billions of dollars of property damage, they did not succeed in breaking our will to carry on. That is what the Field stands for.

It honors the past but looks forward to the future. Hopefully, it meets your expectations. The number of individuals, companies and foundations who contributed to 9-11 Memorial Field over the course of 8 years is simply amazing.

I hope you will visit us often.
