## Report from the April Family Meeting

This newsletter will begin a regular feature of providing a summary from the meetings with the Board of Directors.

*Board President Faith Arter introduced our new Executive Director - David Hastings - who spoke briefly to the families, stressing that he wanted to both learn from and hear from the families on all issues they deemed important.*

*Financial Report - Faith explained the balance sheet and profit and loss statement provided to the families, indicating the funds are separated by their purpose and any restrictions placed on them as a result of their source. For example, particular funds are dedicated to provide assistance to families in certain states and cannot be commingled. She explained that she and David are working on the development of a budget which will outline the program and functional areas the Fund is prioritizing. That budget is in process. One of Faith's priorities is to identify the appropriate amount of reserves to put aside for the purpose of being able to continue specific functions of the organization (for example, the annual commemoration) for the long term.*

*Projects and Programs - David and Social Work Coordinator Diane Nealon presented updates on the following projects:*

*Health Insurance Project - we are working with Blue Cross and Blue Shield of Massachusetts to develop a proposal for subsidizing family health insurance for those who are coming off of COBRA benefits.*

*Remembrance Book Project - Faith has asked David to work closely with the design team to*

identify a time frame and necessary decisions in order to produce a book during the summer. (*more on this later in the newsletter*).

*Family Fitness Day - David spoke about the upcoming May 15 - Family Fitness Day at the Sports Club LA in Boston, encouraging everyone who can to attend (more on that program later in this newsletter)...*

*Boston Center for Adult Education Classes - As detailed in the April newsletter, this program offers a \$50/person/class maximum reimbursement for selected BCAE classes. One family member who wanted to attend a class some months away, but did not want to miss out on the reimbursement program in the event it was used up by then, asked the Fund to consider the request. In response the Fund is going to set-aside reimbursement Funds for families that ask, in advance, with the intention of registering for a course list that is offered later on in the year. David explained that the program was being offered in the hope that groups of individuals might attend classes, providing a social activity as well as personal development. In response to a suggestion from family members present, Faith stated that groups of individuals interested in taking courses together that might be at facilities in other parts of the state should forward their requests to David for consideration of inclusion in this effort.*

*Collaboration and Information Sharing Project for Young People - Diane explained some of the logic behind the upcoming initial gathering of parents and young people in Waltham. She invited parents to come by themselves if their child is not interested in attending, and to also follow-up with her with phone contacts about issues they may*

*Scholarship America* The families present and some board members expressed continued frustration with the lack of responsiveness of the Scholarship America organization. Faith asked David to make this the number one priority, given the proximity to the deadline for application (June 15) and the necessity of being able to put together financial plans for college in the fall for some of our families.

*Needs Analysis Survey* - Diane reviewed the summary data, cautioning the group that this was based on a small sample of respondents, and that we intend to continue gathering additional responses. A suggestion was made to offer the survey instrument on the web. Due to the confidentiality of the material, there are no plans to offer a web-based survey at this point in time. Family members who have not yet submitted a survey are encouraged to do so and can ask Diane for another copy.

*Discussion of a proposal for Family Members to serve as Board Representatives* - Faith summarized the decision taken earlier that evening at the Board member such that the Board will be working to increase the size of the Family Advisory Committee, clarify its roles and responsibilities, and identify a selection method to use in selecting some subset of those Committee members to serve on the Board. She cautioned that such service on the board needs to be designed carefully, to avoid conflicts of interest that could compromise the Fund's ability to follow required state and federal regulation and law. David will be leading an effort to develop proposed policies and procedures for consideration at the June Board meeting.
