Mass 9/11 Fund 17th Anniversary Commemoration Events in Boston

8:30 a.m., Flag Lowering, Moment of Silence and Reading of Names, Front Steps of Massachusetts State House. *This event is by invitation and RSVP is required.*

9:30 a.m., Commemoration Observance & Sweeney Award for Civilian Bravery, Massachusetts State House Chambers of the House of Representatives. *This event is by invitation and RSVP is required.*

This year, we are most privileged to welcome the distinguished Andrew H. Card Jr., White House Chief of Staff under President George W. Bush, as our Keynote Speaker. You will recall that Mr. Card informed President Bush of the breaking events in New York City on the morning of September 11, 2001.

11:00 a.m., Family reception at the Taj Hotel. Trolley service is available from the State House to the Taj Hotel. *This event is by invitation and RSVP is required*.



1:00 p.m., Wreath Laying Ceremony, Boston Public Garden, 9/11 Garden of Remembrance, immediately followed by the One Mission and Red Cross Blood Drive Day of Service events.. *This event is by invitation and RSVP is required.*

Simplified RSVP

Our simplified electronic invitation was emailed on July 19. It contains one large button for each of the four events listed above. You must respond for each event separately, but can print one ticket that covers all the events you plan to attend. Each of the four responses can list up to 20 attendees of whom four can be invited guests who are not family members. Every attendee must have their own printed ticket due to State House security protocols, and will receive an identification lanyard when they present the ticket at their first event. Kindly respond promptly, and remember to list any family members who are not on email.

The commemoration events are expensive to produce and we must pay for family members who sign up for the luncheon in particular but do not attend. We appreciate your help in minimizing our losses by providing accurate numbers and informing us as soon as possible—and no later than August 28—if anyone in your party changes their mind.

Family Participation

We are very busy finalizing details for the 17th Commemoration. Happily, the name reader, bell ringer, and MC roles are already filled.

Announcing Our Very Own Commemorative Bell

The Mass 9/11 Fund now has its very own bell to ring during the Reading of Names ceremony! The handsome bell is engraved with our logo and the words *We Remember*. Best of all, we no longer have to transport borrowed bells to and from the State House.

Media Requests for Interviews

We typically receive many media requests, especially for radio interviews on and around 9/11, and this year promises to be no exception. If you're interested in speaking to the media, kindly respond to Alyse Mazerolle at alyse.mazerolle@massfund.org. Please provide the necessary contact information, including your email address and mobile or home phone number. In addition, you must explicitly state that the Mass 9/11 Fund has your permission to share this information with credentialed requesters even if you have done so in past years.

Your immediate response is required once you receive the email from Alyse. It is extremely important that Alyse has the information ahead of any requests because reporters do not provide much advance notice and their schedules are tight.

One Mission Day of Service Event

Going forward, the Mass 9/11 Fund will increasingly emphasize Community Service. With that in mind, we are planning an event in support of a wonderful charity named One Mission (<u>www.onemission.org</u>). Their cause is doing whatever it takes to get pediatric cancer patients through treatment. One Mission's programs make living in the hospital less lonely and stressful, bring joy in a time of fear and uncertainty, and give kids and their loved ones the support they need to get through the emotional and financial challenges of treatment. A new study by the Centers for Disease Control and Prevention has found that pediatric cancer rates are the highest in the Northeast, with Massachusetts having the 12th highest rate in the country.

One of One Mission's programs is Music Therapy. Music Therapy is the use of music by health care professionals to promote healing and enhance quality of life for patients. The therapy is used to encourage emotional expression, promote social interaction and relieve symptoms. There is some evidence that, when used with conventional treatment, music therapy can help to reduce pain and relieve chemotherapy-induced nausea and vomiting. It may also relieve stress and provide an overall sense of wellbeing. One Mission funds a Music Therapist staff position exclusively for the oncology floor at Boston Children's Hospital.

In honor of September 11th National Day or Service and Pediatric Cancer Awareness Month, we invite you to join us in helping One Mission to care packages for families dealing with cancer. We will meet on the Boston Common immediately following the Wreath Laying ceremony to assemble these care packages.



In advance of the event, we are asking for your kind help in donating items needed for the packages. At this time, we would greatly appreciate donations of journals, notebooks, blank note cards, nice pens, and soft blankets. Other needed items are unscented hand or body lotion (please choose from Aveeno, CeraVe, Lubriderm or Eucerin). Donations can be delivered to or dropped off at either of these locations:

Red Cross Blood Drive Day of Service Event

The Red Cross has scheduled a blood drive on September 11 exclusively for Mass 9/11 family members and friends. The Bloodmobile will be located at 15 Arlington Street, just outside the Taj Boston, from 11:00 am until 5:00 pm. Appointments must be made in advance through <u>www.redcrossblood.org</u>, which provides full details. *Enter sponsor code TajBoston.*

Eligible donors with types O, B negative or A negative blood are especially needed, and are encouraged to make a *Power Red* donation. Power Red donors give a concentrated dose of red blood cells during a single donation, allowing them to maximize their impact.

Your blood donation is more than a unit collected at a blood drive, it's the gift of a life for patients in need: more birthdays, more laughter, and more love. Life is a gift, let's give more of it! We are counting on your support so please schedule your participation today!

Prosecution Team Visit

Brigadier General Mark Martins and Karen Loftus, Director, Victim Witness Assistance Program, visited the Mass 9/11 Fund in Boston on June 30 to meet with families and update us on progress at Guantanamo Bay, Cuba. Hearings for the trial of the five codefendants of *United States v. Khalid Sheikh Mohammed, et al* are ongoing, and the plan is that they will continue through 2019. Currently, the trial is expected to take place in 2020.

General Martins and Director Loftus explained what to expect during the trial, how the process works, and in particular how they are ensuring the defendants are treated lawfully (to head off appeals). They described the experience of visiting GTMO and the facilities, and assured us that family members receive much care and support. They also responded to family concerns during a Q&A session following the presentation.

Hearing sessions are scheduled for one or two weeks each month. Up to five family members may attend each session on site at Guantanamo Bay, and each one is allowed a support person. Family members who have never visited Guantanamo Bay have priority over those who have. Planned attendance is at capacity through November. If you are interesting in attending a hearing session after November, you may contact Director Loftus directly at <u>karen.v.loftus.civ@mail.mil</u>.

Family members can also attend closed circuit television (CCTV) broadcasts of the hearing sessions at the Fort Devens military base in Devens, Massachusetts. If you would like to do so, please contact either Director Loftus or Alyse Mazerolle to schedule your visit.
